OLD BUSINESS

Discussion and vote on the proposal to subdivide the Thomas and Loretta Hartle farm.

Narrative: At its meeting on July 30, the Centre County Agricultural Land Preservation Board tabled a vote on this proposal, pending interpretation of the County's subdivision language. It was unclear to the entire board whether the County's minimum requirements for subdivision were the same as the minimum criteria for a new easement – that is requiring 50 or more acres – and whether the language "10 or more acres if contiguous to a preserved farm" applies post-easement. Doug Wolfgang, Director of the Bureau of Farmland Preservation, said the State takes the position that the property's tract of 10 or more acres will be contiguous to the parent tract from which it is being carved, thus meeting the County's subdivision criteria. The parcel proposed for subdivision must meet all of the other criteria as well: it has to be a solid 10 acres of cropland, pasture land or grazing land. The Hartles' proposal indicates that 10.1 acres of tillable land and pasture in the proposed 12-acre parcel will be maintained for agricultural operations.

Recommendation: That the Board make a final review of the Hartles' proposal, confirm that it meets County and State subdivision criteria, and vote to approve it. If approved, the proposal must go before the State board at its October meeting.
