RESOLUTION 7 OF 2020

A RESOLUTION BY THE BOARD OF COMMISSIONERS OF CENTRE COUNTY, PENNSYLVANIA, AUTHORIZING THE COUNTY ADMINISTRATOR OF THE COUNTY OF CENTRE SIGNATORY AUTHORITY WITH THE COMMONWEALTH OF PENNSYLVANIA, DEPARTMENT OF TRANSPORTATION.

WHEREAS, the County of Centre entered into an agreement with Highway Safety Network, Inc. on April 10, 2018 to apply for funding for through the Pennsylvania Department of Transportation for the District 2-0 Community Traffic Safety Project; and

WHEREAS, Highway Safety Network, Inc. is a Non-Profit Cooperation organized and existing under laws of the Commonwealth of Pennsylvania; and

WHEREAS, the Centre County Board of Commissioners adopted Resolution 16 of 2018 authorizing Chief Elected Official Michael Pipe, Chair or appointed designee Margaret N. Gray, County Administrator to sign a grant agreement with the Pennsylvania Department of Transportation, Program Services Division, Bureau of Maintenance and Operations to fund the District 2-0 Community Traffic Safety Project; and

WHEREAS, in the agreement of April 10, 2018, Highway Safety Network, Inc. assures the County of Centre that they will undertake all activities relating to the above referenced project to fulfill the goals and objectives as required by the Pennsylvania Department of Transportation; and

WHEREAS, Highway Safety Network, Inc. has requested restricted access to the Pennsylvania Crash Information Tool for Community Traffic Safety Project Coordinators;


BE IT RESOLVED, by the authority of the Board of Commissioners for Centre County, it is hereby resolved by the Municipality of the same, that Margaret N. Gray, County Administrator be authorized and directed to sign on its behalf any and all agreements entered into with the Commonwealth of Pennsylvania, Department of Transportation. Such agreement will provide the Highway Safety Network, Inc. with any or all access to resources provided by the Department of Transportation to use in conjunction with grant related activities.


