The Grassland Evaluation Contest began in 2003 in an attempt to inspire high school students to learn practical and profitable ways to graze livestock on their family farms. The first contest was held at the Penn State beef sheep farm and is currently held at the Ag Progress Days site. Over **\$41,000 has been awarded** as scholarships since 2003.

## What is the Grassland Evaluation Contest?

The PA Grassland Evaluation Contest is a competition aimed at educating youth about the **value and benefit of grazing**, as well as, other conservation practices.

Students who **attend the Grassland Evaluation Contest** compete in a variety of

### Contest Categories

- Grassland Condition
- Plant Identification
- Soils Evaluation
- Wildlife Habitat Evaluation



### Who Can Participate

PA high school students, enrolled in grades 9 through 12 which includes non-traditional schools (home, cyber, and charter), enrolled in FFA and 4-H programs, or school affiliated club. Photo waivers will be required. Note: Only FFA or 4-H programs can participate at the national competition



### Why Students Participate

Contest teams consist of 3 to 4 members who compete on an individual basis, rotating through 4 contest stations. Winning teams and top scoring students receive scholarships **toward higher education.**

## About the Grassland Contest

The contest consists of four topics based on a selected pasture that is 50ft x 50ft:

**Soils Evaluation:** Each student is asked to identify the soils in the pasture, calculate slope, and answer questions based on the soil type in the pasture.

**Grassland Condition:** Each Student evaluates a pasture and is given a grazing scenario to calculate dry matter needs and forage availability and makes recommendations based on their findings.

**Wildlife Habitat Evaluation:** Each student is asked to answer questions about how the pasture affects wildlife.

**Plant Identification:** Each student has to identify 20 plants that are typically found in Pennsylvania pastures.
