LOW-FEE ATTORNEY REFERRAL PROGRAM

The Low-Fee Attorney Referral Program is comprised of four lists (Criminal, Civil, Family, and Wills/ Estates/ Guardianships) that are made available to potential clients who have indicated a need for low fee representation. You will need to contact the attorneys listed to determine whether they handle your legal issue.

The attorneys who are on this list have agreed to offer an initial one-half hour (30 minute) consultation at no charge. Any fees charged by the attorney after the initial consultation will be determined by the attorney and the client and will be memorialized in a formal fee agreement that both attorney and client will sign. Some practice areas have specific guidelines regarding how fees are determined or said fees may need to be approved by the court. The participating attorneys reserve the right to make a determination regarding a client's ability to pay and/or options to pay. Please keep in mind that an initial consultation does not establish an attorney/client relationship.
