

Ordinance No. 2 of 1999

This Amendment to the Centre County Subdivision and Land Development Ordinance (Ordinance Number 3 of 1983) is for the purpose of adding a new Section 1104 to Article XI, Requirements for Special Conditions. The new Section is entitled, "Stormwater Requirements for the Fishing Creek/Cedar Run Watershed-Act 167 Stormwater Management Plan." It shall read as follows:

Purpose and Intent: It shall be the purpose and intent of Section 1104 to provide for the implementation of the Watershed Stormwater Management Plan by providing special requirements and standards for the areas of Centre County which are contained within the Fishing Creek/Cedar Run Watersheds. The municipalities that are included are the townships of Gregg, Marion, Miles, and Walker. (Spring Township has adopted its own requirements.)

It is the intent of the above listed municipalities, the Centre County Board of Commissioners, and the Centre County Planning Commission that the "Act 167 ordinance requirements" for the above-referenced Stormwater Watershed Management Plan be delegated by the watershed municipalities to the County of Centre for administration and enforcement by the Centre County Planning Commission through its enforcement of the Centre County Subdivision and Land Development Ordinance. Each municipality, with the exception of Spring Township, has by formal action delegated its responsibilities. The County of Centre has officially adopted the Stormwater Plan by Resolution No. 10 of 1998, and fully intends to accept the delegation of responsibility from the local municipalities. The plan was subsequently approved on July 22, 1998 by the Bureau of Watershed Conservation, PA Department of Environmental Protection, by public notice in the PA Bulletin, Vol. 28, No. 36, September 5, 1998.

It shall further be the purpose and intent of Section 1104, to reference certain watershed delineation overlay maps which shall become an official part of this Amendment by reference.

These overlay maps shall be described as follows:

1. Map of Centre County, entitled: Fishing Creek Watershed-Little Fishing Creek-Cedar Run.
2. Map of the Fishing Creek Watershed, Centre and Clinton Counties, including the Little Fishing Creek, Cedar Run, and Roaring Run Subwatersheds in Centre County.
3. Fishing Creek Watershed: Gregg Township.
4. Fishing Creek Watershed: Marion Township.
5. Fishing Creek Watershed: Miles Township.
6. Fishing Creek Watershed: Spring Township
7. Fishing Creek Watershed: Walker Township.

The specific terms and conditions for the submission of a Stormwater Watershed Management Plan shall be referenced to Chapter 11, Fishing Creek/Cedar Run Watershed Act 167 Stormwater Management Model Ordinance, as contained in the adopted Fishing Creek/Cedar Run Watershed Act 167 Stormwater Management Plan. (As appropriate, Ordinance No. \_\_\_\_\_ of 1999 defines as follows: the Plan Administrator shall be the Centre County Planning Office; and references to the Conservation District shall mean the Centre County Conservation District.) All sheet sizes and formats shall be consistent with the Centre County Subdivision and Land Development Ordinance.
